Magnus T. Bernhardsson, Ph.D. Professor, Middle Eastern History and Chair, International Studies, Williams College Williamstown, MA

Dr. Magnus Bernhardsson specializes in the modern Middle East, specifically the political and cultural history of Hashmite Iraq (1921-1958).
