Meniscectomy is the most common orthopedic procedure performed in the United States. The sequelae of meniscectomy are well established, and the incidence of osteoarthritis in the population is only growing. The importance and cost effectiveness of meniscus repair has been described in the literature, but still only encompasses about 15% of all meniscus surgeries. This instructional course will evaluate the role of meniscus repair and replacement. Discussion will focus on the following specific points: (1) trends in meniscus repair: key techniques, augmenting meniscus repairs, upcoming basic science, (2) difficult tear patterns: how to approach horizontal cleavage tears, radial tears, and complex tears, (3) the Root Tear Epidemic: who should we fix and how to get the best outcomes, and (4) time to transplant: patient selection and concepts for success.

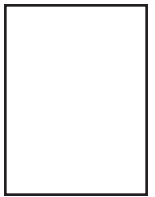
